



Economy


Exports up by 70.2% y/y in April 2021

In April 2021, exports surged by 70.2% y/y to US\$ 378.3mn after increasing by 30.6% y/y in previous month. Notably, exports were also up by 21.7% compared to April 2019 level. Imports increased by 56.5% y/y to US\$ 749.1mn, after growing 18.5% y/y in previous month. As a result, trade deficit widened by 44.7% y/y to US\$ 370.7mn in April. Overall in 4M21, trade deficit was up by 3.6% y/y to US\$ 1.5bn, as exports increased by 19.6% y/y to US\$ 1.2bn and imports increased by 10.1% y/y to US\$ 2.7bn.










Corporate Eurobonds: Bank of Georgia Group Eurobonds (GEBGG) closed at 3.04% yield, trading at 106.21 (-0.24% w/w). Georgia Capital Eurobonds (GEOCAP) were trading at 101.33 (-0.25% w/w), yielding 5.61%.



Bank of Georgia Group (BGEO LN) shares closed at GBP 11.10/share (unchanged w/w and -1.60% m/m). More than 196k shares traded in the range of GBP 10.80 - 11.30/share. Average daily traded volume was 39k in the last 4 weeks. The volume of BGEO shares traded was at 0.40% of its capitalization.

Georgia Capital (CGEO LN) shares closed at GBP 6.25/share (+5.04% w/w and +5.93% m/m). More than 503k shares traded in the range of GBP 5.78 - 6.57/share. Average daily traded volume was 57k in the last 4 weeks. The volume of CGEO shares traded was at 1.05% of its capitalization.

TBC Bank Group (TBCG LN) closed the week at GBP 10.86/share (+3.63% w/w and -2.86% m/m). More than 124k shares changed hands in the range of GBP 10.36 - 10.90/share. Average daily traded volume was 82k in the last 4 weeks. The volume of TBCG shares traded was at 0.23% of its capitalization.
