


Weekly Market Watch

Economy

International reserves down 2.2% y/y in March 2020

Gross international reserves declined by 2.2% y/y to US\$ 3.4bn in March 2020, according to NBG. On a monthly basis, reserves were down 1.1%. The monthly decline in reserves was attributed to US\$ 100mn sale by NBG on FX auction in March. Other changes in reserves were related to government and banking sector FX operations and/or asset revaluation.





Ministry of Finance Benchmark Bonds: 2-year GEL 70.0mn (US\$ 22.1mn) Benchmark Bonds were sold at the auction held at NBG on April 7, 2020. Total demand was 1.5x higher and the weighted average yield was fixed at 10.17%, up 1.33ppts from previous auction held on March 2, 2020. The nearest treasury security auction is scheduled for April 14, 2020, where GEL 50.0mn nominal value 1-year T-Bills will be sold.


Ministry of Finance T-Bills: 6-month GEL 20.0mn (US\$ 6.3mn) T-Bills were sold at the auction held at NBG on April 7, 2020. Total demand was 2.4x higher and the weighted average yield was fixed at 8.983%, down 0.03ppts from previous auction held on March 2, 2020.





Nominal effective exchange rate and Real effective exchange rate 120 115 110







Fixed income

Corporate Eurobonds: Bank of Georgia Group Eurobonds (GEBGG) closed at 4.59% yield, trading at 104.24 (+1.58% w/w). Georgia Capital Eurobonds (GEOCAP) were trading at 91.28 (-1.48% w/w), yielding 8.81%.

GOGC Eurobonds (GEOROG) were trading at 96.09 (-0.40% w/w), yielding 10.84%. Georgian Railway Eurobonds (GRAIL) traded at a premium at 100.09 (+0.02% w/w), yielding 7.70%.

Georgian Sovereign Eurobonds (GEORG) closed at 101.01 (-0.04% w/w) at 5.81% yield to maturity.


Equities

Bank of Georgia Group (BGEO LN) shares closed at GBP 9.93/share (+9.60% w/w and - 29.07% m/m). More than 453k shares traded in the range of GBP 8.50 - 10.16/share. Average daily traded volume was 129k in the last 4 weeks. FTSE 250 Index, of which BGEO is a constituent, gained 13.65% w/w and lost 6.49% m/m. The volume of BGEO shares traded was at 0.92% of its capitalization.


Georgia Capital (CGEO LN) shares closed at GBP 5.42/share (+29.05% w/w and -12.01% m/m). More than 299k shares traded in the range of GBP 4.10 - 5.67/share. Average daily traded volume was 53k in the last 4 weeks. The volume of CGEO shares traded was at 0.82% of its capitalization.


