Economy

Exports up 34.2% y/y in April 2019


In April 2019, exports increased 34.2% y/y to US\$ 307.4mn, while imports were down 0.5% y/y to US\$ 731.0mn and the trade deficit narrowed 16.2% y/y to US\$ 423.6mn, according to Geostat. In April 2019, copper (+268.1% y/y), cars (+98.8% y/y), ferro-alloys (-26.9% y/y), pharmaceuticals (+140.4% y/y) and wine (-0.7% y/y) were the top 5 exported commodities. A 26.1% of exports was directed to the EU (+148.3% y/y), 52.2% to the CIS (+26.3% y/y) and 21.7% to other countries (-4.5% y/y).

In April 2019, copper (+76.9% y/y), petroleum (-5.7% y/y), cars (+1.4% y/y), pharmaceuticals (+22.4% y/y) and gases (+32.1% y/y) represented the top 5 imported commodities.

Overall, in 4M19, the trade deficit was down 14.0% y/y at US\$ 1.6bn as exports were up 17.9% y/y to US\$ 1.1bn, while imports decreased by 3.1% y/y to US\$ 2.7bn.

Producer price index up 5.7% y/y in April 2019

Annual PPI was up 5.7% in April 2019 after increasing 5.4% in previous month. Rising prices in manufacturing (+6.7% y/y) contributed the most to the overall index change. In this category, the price growth was impacted by price increase in food products, beverages and tobacco products (7.8% y/y), basic metals and fabricated metal products (4.9% y/y) and for pulp, paper and paper products (16.6%).








Refinancing loans: National Bank of Georgia (NBG) issued 7-day refinancing loans of GEL 730mn (US\$ 263.0mn).




Fixed income

Corporate Eurobonds: Bank of Georgia Group Eurobonds (GEBGG) closed at 5.44% yield, trading at 102.04 (+0.22% w/w). Georgia Capital Eurobonds (GEOCAP) were trading at 95.20 (+0.03% w/w), yielding 7.33%.

GOGC Eurobonds (GEOROG) were trading at 103.77 (+0.13% w/w), yielding 4.66%. Georgian Railway Eurobonds (GRAIL) traded at a premium at 107.56 (+0.05% w/w), yielding 5.09%.

Georgian Sovereign Eurobonds (GEORG) closed at 105.79 (-0.24% w/w) at 3.64% yield to maturity.




Bank of Georgia Group (BGEO LN) shares closed at GBP 16.86/share (+3.75% w/w and +3.37% m/m). More than 286k shares traded in the range of GBP 16.00 - 17.29/share. Average daily traded volume was 69k in the last 4 weeks. FTSE 250 Index, of which BGEO is a constituent, lost 1.90% w/w and 4.33% m/m. The volume of BGEO shares traded was at 0.58% of its capitalization.


Georgia Capital (CGEO LN) shares closed at GBP 9.75/share (-0.81% w/w and -3.47% m/m). More than 634k shares traded in the range of GBP 9.48 - 10.30/share. Average daily traded volume was 118k in the last 4 weeks. The volume of CGEO shares traded was at 1.67% of its capitalization.

TBC Bank Group (TBCG LN) closed the week at GBP 16.54/share (-2.48% w/w and +8.53% m/m). More than 102k shares changed hands in the range of GBP 16.40 - 17.00/share. Average daily traded volume was 19k in the last 4 weeks. The volume of TBCG shares traded was at 0.19% of its capitalization.

Georgia Healthcare Group (GHG LN) shares closed at GBP 2.45/share (+4.26% w/w and +16.67% m/m). More than 42k shares were traded in the range of GBP 2.31 - 2.45/share. Average daily traded volume was 18k in the last 4 weeks. The volume of GHG shares traded was at 0.03% of its capitalization.
